

SERVICE COMMITTEE

December 2, 2024

The December 2, 2024 Service Committee meeting was called to order at 5:30 p.m. in Council Chambers by Dale Rowe, Chairman. Service Committee members present were Aaron Korte, Dale Rowe, and Andy Voorheis.

Others present included: Kyle McColly, Mayor; Dave Schneider, Collections System Supervisor; Brad Taylor, Street and Sanitation Supervisor; John Walker; Brian Hemminger, Daily Chief Union; and Sarah Bennett, Clerk.

The summary of bills totaling \$143,356.36 was presented.

A motion was made by Mr. Voorheis, seconded by Mr. Korte, for the approval and payment of bills totaling \$143,356.36. Upon Voice Vote, all members voted Yes. The Chairman declared the motion carried.

The minutes of the November 18, 2024 Service Committee meeting, having been mailed to each Service Committee member, were approved as received.

It was reported that Mayor McColly and Mr. Taylor will be meeting with a representative this week to get a quote on a new garbage truck with a tipper arm and garbage cans for residents. Mr. Taylor will also obtain an updated quote for the street maintenance building to house the new garbage truck.

Mr. Taylor reported that leaf collection within the City continues as last week the first round was completed and the leaf crew is currently working on the second round which should be completed by the end of this week and next week the third and final round will begin.

Mr. Schneider reported that an air valve at the Wastewater Treatment Plant went bad today but it has been repaired.

Mayor McColly reported on behalf of Mr. Doug Keller, Wastewater Treatment Plant Supervisor, that Mr. Keller continues to work with Peterman Associates on a long-term control plan to meet an upcoming deadline.

Mayor McColly also reported that he along with Mr. Keller and Mr. Ben Buckland, Law Director, will be meeting on Wednesday, December 4, 2024 at 1:30 p.m. to review a proposed new agreement with the Louis Dreyfus Company for the Valencia soybean processing plant to make sure it's an accurate reflection of the City's expectations of the project. Mayor McColly invited Service Committee members to attend this meeting. A meeting with representatives from the Louis Dreyfus Company will be held on Monday, December 9, 2024 to review the agreement.

Mayor McColly indicated that Mr. Dave Peterman will be in town this week to conduct surveying for the Valencia soybean processing project.

Mayor McColly further reported that health insurance meetings for existing City employees will take place tomorrow at the Water Treatment Plant at 9:00 a.m. and 2:00 p.m.

Mayor McColly again noted that everyone needs to complete the I.T./Security training provided by the AME Group.

There being no further business, the Chairman declared the meeting adjourned.
